

## We Had A Crystal Ball... or Just Guessed Right


# **Urgent Practice Data Survey (N.C.)**

## Financial Report (e.g., Week of April 27)

What does your practice revenue look like today compared to your normal (pre COVID-19) practice revenue?



2%.....No Change


8%..... Decrease of 25% or less

38% .. Decrease of 26% to 50%

**34%** .. Decrease of 51% to 75%

18%...Decrease of more than 75%

Did your practice apply for the 1st Round of funding through the PPP?



Paycheck Protection Program funds provided a vital lifeline to many practices that had seen a potentially catastrophic decline in revenues.

11% .... No my practice was not eligible

6% ..... No my practice was not interested

1% ..... No I didn't complete the application in time

1%.....Yes but my application was denied

23% .. Yes but I was told no funds were available

10%...Yes but I never received a response

48% .. Yes and we received financial assistance

# **Unprecedented Protection and a Booster Shot for Health Care: S 704** (70 pgs; not just health care)

### » Part III. Healthcare:

- -G.S. § 90-21.133 grants civil immunity (protections from being sued for malpractice) to <u>all</u> healthcare providers and healthcare entities providing <u>any care</u> to any patient, for any reason, during the state's declared COVID-19 emergency.
  - » Exceptions for gross negligence and intentional acts



# Unprecedented Protection and a Booster Shot for Health Care: S 704 (70 pgs; not just health care)

-G.S. § 66-640 grants civil immunity (protections from being sued by either your own employees or by your patients) to all "essential businesses" (healthcare practices/facilities are by definition "essential businesses") for claims for any injury or death alleged to have been caused by the person contracting COVID-19 ... while getting care from ... or while employed by the practice/facility.



### **Project:**

- » Assembled multi-disciplinary experts and leaders
- » Community research and info-gathering meetings state-wide
- » Developed and prioritized common set of health indicators and targets for NC over next decade
- » DHHS, NCGA, and Governor to use for population health improvement plan
